COVID-19 Safety in The Grand Theatre

Chippewa Valley Theatre Guild is thrilled to re-open our doors and welcome the community back to enjoy quality theatre experiences! The following precautions are for the safety of all volunteers, staff, students, and audience members entering The Grand Theatre. This policy is effective March 21, 2022 through June 26, 2022 and will be reviewed and updated regularly as pandemic risks and public health guidance shift.

Vaccination

- Patrons, artists, and crew are strongly encouraged to be vaccinated* for COVID-19 and boosted if eligible.
- All staff, class instructors, and ushers are required to be fully vaccinated for COVID-19 and encouraged to be boosted if eligible.

Masks

- Regardless of vaccination status, masks[‡] are encouraged for all patrons and students 2 years old and older. Masks may be removed briefly to eat or drink. Masks will be available at the door.
- On performance dates, masks are required of all non-performing staff and volunteers, including crew and ushers.
- Masks are required for all auditions and encouraged during rehearsals and classes.

Hand Washing and Hand Sanitizing

- Hand washing and sanitizing are encouraged, and hand sanitizer will be available at every entrance, as well as near food sales.

Additional Precautions

- Playbills will be single-use and placed on the chairs for each performance.
- Staff and volunteers will sanitize high-contact surfaces including railings, doorknobs, handles, and chairs before and between each audition and performance.
- Please cover all coughs and sneezes.

Please Stay Home If...

...you are feeling ill or have within the last 5 days tested[†] positive for COVID-19 infection, regardless of vaccination status.

...in the last 5 days, you have been exposed to someone who has tested positive for COVID-19 infection AND you are *unvaccinated or not up-to-date on your vaccines* (eligible for a booster but not yet boosted).[§]

*Fully vaccinated = 2 weeks after the 2nd dose of the Pfizer/BioNTech (Comirnaty) or Moderna vaccines OR 2 weeks after the only dose of the Johnson & Johnson vaccine; Find vaccine information: [vaccines.gov](https://www.vaccines.gov)

[‡]Acceptable masks are well-fitted medical or multi-layered cloth masks that cover both the nose and mouth. Face shields will not be allowed as a substitute.
